

SEVENTH BEND EASTER BONUS: \$15,000 PRE-PAID GIFT CARD PROMOTION

TERMS AND CONDITIONS

1. The Promotion

2. Conditions of Entry

- (b) have completed the cooling off period under the Contract of Sale prior to Sunday, 28 April 2019 at 11.59pm AEST;
- (c) comply with all terms and conditions set out in the Contract of Sale at all times prior to settlement; and
- (d) complete settlement in accordance with the terms and conditions set out in the Contract of Sale.

3.2 An individual purchasing one of the Lots set out in clause 3.1 of these Terms and Conditions by way of a house and land package through a builder must fulfil all Terms and Conditions contained herein in order to enter the Promotion.
